## Friend of Public Health

Dr William Emery was presented with the 2006 Friend of Public Health Award by the Board of Health in May, 2006. The Friend of Public Health Award, presented annually, was created in 2000 to honor an individual or organization who has made outstanding contributions to the health of the community while reflecting the health department's mission to enhance the health of Berrien County residents.

"It was the unanimous feeling and vote of the Board of

Health that no other individual in Berrien County was more deserving of this year's award," said Duane McBride PhD, Chair of the Board of Health upon presenting the award to Emery.

"Dr. Emery's years of service to the residents of our county as a member of the Board of Health for 15 years, and the leadership he has provided as a founding member of the Healthy Berrien Consortium exemplify the true spirit in which the award was created,"

McBride said.

Besides being a family physician, Emery served as medical director for Whirlpool Corporation for 37 years. He has served as adjunct instructor at Western Michigan University, teaching in the areas of health systems and policy.

## MDCH Director's Award to Berrien County

The Nurse-Family Partnership (NFP) program was recognized as Michigan's best community health improvement program in 2006. The Michigan Department of Community Health (MDCH) Director's Award is presented annually to local health departments for programs of innovation and excellence in public health. The award was accompanied by a trophy and \$5,000 which will be used to purchase developmental items such as books.

NFP is one of several reasons that the county has been successful in reducing the infant mortality rate over the past six-years. Berrien County went from being ranked highest in the state to below the state average.

The **NFP** program services were provided to 165 families of 1<sup>st</sup> time pregnant women in Berrien County in 2006. Since start-up in 2000, 304 babies have been born to NFP pro-

gram participants. Some outcomes of interest - 93% were born at or above 2500 grams; 92% were born at or more than 37 weeks gestation; and 55% initiated breastfeeding.

The Berrien County NFP program is a partnership program of the United Way of Southwestern Michigan. In addition, funding is provided through the Michigan Department of Community Health.

## Project Public Health READY!

BCHD received national recognition for being ready to face bioterrorism, new epidemics, natural disasters and other public health emergencies. The National Association of County and City Health Officials (NACCHO) recognized a total of only seven (7) local health departments and regional partnerships nationwide in 2006 for being Project Public Health Ready (PPHR).

Project Public Health Ready is a tool that measures preparedness. PPHR prepares local public health departments to respond to emergencies and to protect the public. Through PPHR, local health departments (LHD) develop concrete evidence to demonstrate capability to respond to emergencies through all-hazards response plans, and competency-based training and exercises.

## Infant Mortality Reduction Task Force

**The Raising Up Healthy Babies (infant mortality reduction) Taskforce** continued its communitywide efforts to keep more babies alive and well. Activities for 2006 included: (1) Hosting an Infant Mortality Summit in March; (2) Conducting a poster campaign to promote prenatal care, safe sleep and good nutrition; (3) A Jam Jar Festival in remembrance of babies who have died in Berrien County and to celebrate healthy births; (4) Baby's Own Bed portable crib distribution campaign; and (5) the

Initiation of the House to House (H2H) healthy pregnancy peer education program.

The **Baby's Own Bed** program continued to help to improve the county's infant mortality rate. **The Taskforce purchases and distributes portable cribs for new (eligible) parents who otherwise would have no safe place for their infants to sleep.** The Heart of Cook Foundation (American Electric Power) awarded a grant in the

amount of \$2,500 to purchase 62 beds.

The Raising Up Healthy Babies Task Force, along with Baby's Own Bed, Nurse Family Partnership and Fetal Infant Mortality Review Boards are working hard to assure that any baby born in Berrien County can expect a safe and healthy infancy.

## Lead Safe Kids Coalition

The Lead Safe Kids Coalition was established to end childhood lead poisoning in Berrien County. Initial efforts targeted Benton Harbor's Census Tract V, where lead poisoning is extremely high among children. Interventions included a state funded **education and outreach door-to-door campaign** in October that reached 1,000 homes as well as **lead training and certification** for two environmental health specialists. The Out-

reach blitz occurred during Lead Poisoning Awareness Week from October 22-29. Approximately 20 volunteer canvassers went door-to-door in Census Tract V in Benton Harbor to provide lead poisoning awareness information. 850 bags containing lead poisoning literature were distributed.

The Lead Safe Kids Coalition meets monthly to discuss ways to keep children in Berrien

County, especially those in Benton Harbor's Census Tract V, safe from the harmful effects of ingesting lead.

## Community Alliance Against Substance Abuse

**Community Alliance Against Substance Abuse (CAASA)** secured a five year (\$100,000 per year) grant from the Substance Abuse and Mental Health Services Administration (SAMHSA) to continue its mission to achieve a common vision of eliminating substance abuse among youth. Additionally, the Governor's Discretionary Grant through the Office of Drug Control Policy (ODCP) funded CAASA in the amount of \$100,000 for FY

2006. The ODCP grants are awarded to agencies that have worked to foster safe and drug free environments for children while promoting academic achievement.

**CAASA Goals:** (1) To empower youth, families and the community to make healthy, drug-free choices. (2) To become a centralized resource for substance abuse data and prevention programming guidance and assistance. The Goals

are to be achieved through the four (4) Committees of CAASA including: (1) Parent Advisory; (2) Youth Advisory; (3) Systems Coordinating; and (4) Public Relations/Public Policy.

## How the Health Department Serves You

Berrien County Health Department has five service areas committed to the mission to prevent disease, prolong life, protect the health of the community, and promote optimal quality of life for the citizens of Berrien County. The basic functions of the health department remain constant, but some administrative changes were made. **The Division of Community Health Planning** was created with the Administrative Re-organization of BCHD that was initiated in December 2006. With the

creation of the Division of Community Health Planning, the Department has completed a long-term strategic planning goal of instituting the required components for the public health core functions of assessment, policy development and assurance.

**Smoke Free Berrien.** Under the direction of the *Healthy Berrien Consortium*, a Smoke Free Berrien Partnership was established and MDCH grant funding was secured for the purpose of **eliminating second hand smoke in Berrien**

**County.** A proposed Berrien County Clean Indoor Air Regulation received Board of Health approval on December 6 and is awaiting discussion and consideration for approval by the County Commissioners. The proposed regulation, if approved, would prohibit smoking in all public places and all public and private businesses except bars and restaurants in Berrien. (Post Script: Regulation received Board of Commissioners approval on March 1, and will take effect on June 1, 07!)

## Environmental Health Services

Training of specialized Environmental Health Services staff for the **Private and Type III water supply program (Private Wells)** was completed. This ensures that timely pre-drilling site inspections are completed to properly site new wells. After installation, wells are inspected and sampled to make sure water meets public health standards. The BCHD program was evaluated by the Michigan

Department of Environmental Quality in August of 2006 and all Minimum Program Requirements were met.

**Surface Water Sampling.** Environmental Health Services completed **weekly sampling of 13 public beaches** in Berrien County from June through August of 2006. Bacteria sampling was done to determine if surface water quality meets state standards for swimming.

Berrien County beaches consistently meet state standards and none were closed during the 2006 bathing beach season.

## Community Preventive Health Services



Hand Washing is the first step in prevention of many infectious diseases.

**Vaccinations.** 11,297 vaccines were administered to children and adults in Berrien County. 63% of children 19-35 months of age who reside in Berrien County were fully immunized (70% is the goal set by MDCH to attain). 99% of school entrants and 6<sup>th</sup> graders were compliant with receiving the required immunizations. Additionally, 98% of day care and pre-school children were compliant with the required immunizations. (The compliance

levels set by the State are 95% for school entrants and 90% for day care/pre-school.)

**Hand Washing.** The Berrien County Health Department worked in conjunction with the Berrien County Youth Fair to promote good hand washing practices during fair week in August. Hand washing is the first step in prevention of many infectious diseases, but preventing E. Coli infection is the primary concern when residents

are in close contact with farm animals. The Health Department purchased a hand washing station that was set up in the *Wonders of Birth Barn* and staffed a booth in the same location to promote hand washing among patrons of the fair.

## Substance Abuse Treatment Services

**The Women's Specialty Services Program of Substance Abuse Treatment Services (SATS)** receives special funding through the Lakeshore Coordinating Council (LCC) to meet the needs of eligible women and children. In addition to substance abuse counseling, the program helped Berrien County women and their children in 2006 directly with \$14,420 worth of financial assistance for such things as rent and utility bill assistance, medical assistance, prescription drug assistance, furniture/

household appliances, and dental assistance.

**The Inspiration House**, a transitional house that provides women committed to recovering from substance abuse with a drug free place to live, received a grant to continue its mission. The Michigan Department of Community Health (MDCH) awarded \$144,947 to the Berrien County Health Department to continue its partnership with the Citizen's for Progressive Change (CPC) for the continued operation of

this transitional house located in Benton Harbor. CPC hires and supervises a 24-hour staff.

Since it opened in 2005, the house has been funded by grants from MDCH's Office of Drug Control Policy.

## Health Promotion Services

**Smoking Cessation** programs were presented to Berrien County residents as the result of funding through the **Berrien Community Foundation** (\$8,000) and the **Michigan Gateway Community Foundation** (\$4,500).

Adult Cessation – 17 adults completed smoking cessation classes.  
Youth Cessation – 25 youth completed smoking cessation classes.

The BCHD initiated TIPS, Training for Intervention Procedures, in 2006 which is a nationally recognized alcohol management certification available to alcohol vendors. The program is designed to help any and all types of alcohol vendors in regards to the serving of alcohol.

TIPS was chosen as the vendor education program in Berrien County because it uses the best practice option of skill

based training. The program incorporates real world situations along with role plays to ensure each participant walks away from the training with a new skill. It was also chosen for Berrien County based on its acceptance by the commissioners of the Michigan Liquor Control Commission (MLCC). Also TIPS is constantly being improved on and updated based on the ever changing alcohol retail market.

## Personal Preventive Health Services

Two hundred sixty-six (266) women received critical screening as part of the **Breast and Cervical Cancer Control Program (BCCCP)**. (Over 230 in 2005). Early detection is the best defense against breast and cervical cancer. The Southwest Michigan Breast and Cervical Cancer Control Program (BCCCP) provides cancer screening on an annual basis to help women detect breast or cervical cancer at an early stage. Women age

40 and older may qualify to receive a mammogram, breast examination, pelvic examination, and/or Pap test under BCCCP.

**Breast Feeding Peer Counselor:** Berrien County was chosen as a pilot site for a breast-feeding peer counselor program and has received \$36,635 from the Michigan Department of Community Health (MDCH) to hire a full-time counselor to encourage

women to nurse their babies for up to a year. The program targets clients of Women, Infants and Children (WIC). The project goal is to increase the percentage of women who breast-feed their babies at birth from 48.9% to 54% and the number who nurse for six months from 13.6% to 18 %.

## Berrien Health Plan and Prescription Drug Plan

**Berrien Health Plan:** The primary purpose of the Berrien Health Plan, initiated in 2004, is to improve access to health care by providing covered health services for low income people who typically fall through the cracks of the system. BCHD continues to provide outreach and enrollment services as well as health education to the 850 currently enrolled participants. The Berrien Health Plan B offers discounts for doctors of-

fice visits, specialty services, lab tests and X-rays and prescription medications.

**Discount Prescription Drug Program:**

A new discount prescription program for Berrien County residents who have no other prescription drug coverage was initiated by the Board of Directors of the Berrien Health Plan in 2006. The discount program is a way for county residents who lack drug coverage to get

medicine for less (about 20%) at participating pharmacies. Enrollment is coordinated by the Berrien County Health Department.

## New Technology: GAPS at the School Based Clinic

The GAPS assessment tool is used by the Nurse Practitioner (NP) at the School Based Clinic (SBC) to identify the health needs of the student. An electronic adaptive version of the GAPS questionnaire was initiated in 2006 through a partnership with MedNet Systems\*. MedNet Systems developed the questionnaire software, provides tech support as needed, and has even donated the laptop computers used by the students and the NP

The electronic GAPS format

provides several advantages over the paper format: (1) The **NP's interaction with the student is enhanced** because during the visit the NP can focus immediately on that student's specific negative behaviors; (2) The students are receiving **more exposure to computer technology** through the use of the laptops and it appears **students are more open** regarding their behaviors when using the computer than if they were responding to the clinician during a face-to-face interaction; (3)

Because of the nature of the adaptive questionnaire a **more detailed history is obtained and data collection is enhanced**; and (4) The **ability to generate accurate reports** regarding students' behaviors is also enhanced.

## New Services: PlanFirst!

As part of the State's goal to prevent unintended pregnancies, the Michigan Department of Community Health (MDCH) initiated a plan to provide family planning services to women – ages 19 through 44 – who otherwise would not have medical coverage for these services through PlanFirst! Enrollment for the state's new PlanFirst! program began July 1 after the Federal government approved Governor Gran-

holm's request for a Medicaid waiver to fund the program. It is estimated that 200,000 women at or below the 185% of poverty who reside in Michigan and meet Medicaid eligibility could benefit from the extension of family planning services through PlanFirst!

Cost savings: It is estimated that each public dollar spent to provide family planning services saves \$3 that would otherwise

be spent in Medicaid costs for pregnancy-related care for newborns. The services of PlanFirst! provide cost-savings solutions for the Medicaid program, as well as prevent unintended pregnancies.

## New Initiatives: House to House Program

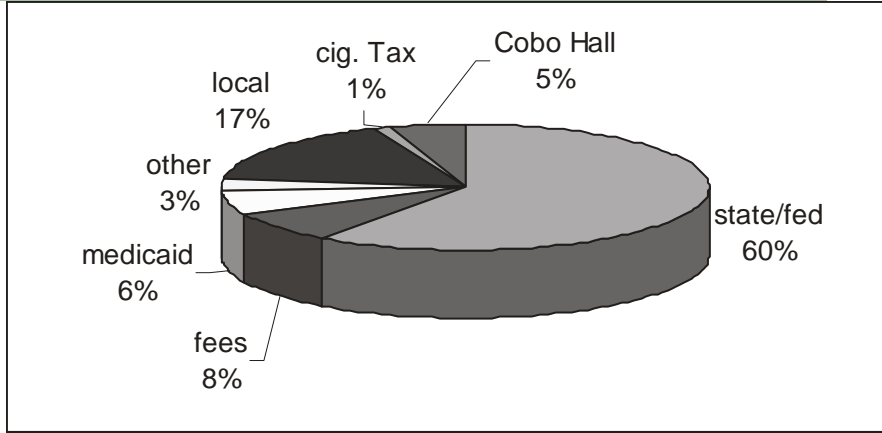
The House to House (H2H) project was initiated in Berrien County by the Raising Up Healthy Babies (infant mortality reduction) Taskforce in 2006. H2H was designed and implemented to provide education and outreach to Benton Harbor/Benton Township women of childbearing age who are at high risk for infant mortality and birth defects. At a H2H gathering, Health Promoters (peer educators) provide group education, primarily provided

in the home setting, focusing on healthy pregnancies, prenatal care, cessation of substance abuse (including tobacco and alcohol), safe sleep, good nutrition, and recognition of pre-term labor. A total of 39 educational sessions were conducted with 395 participants attending.

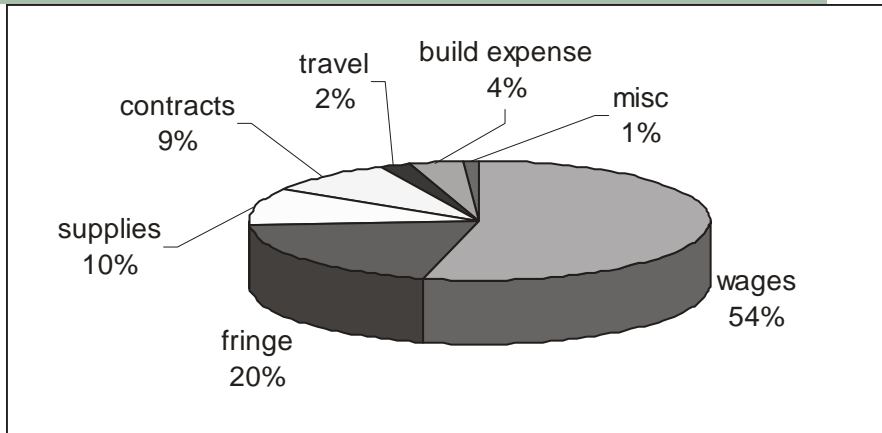
Funding for the project in the amount of \$21,000 was provided by the March of Dimes of Michigan.

**Expenses \$7,087,117**



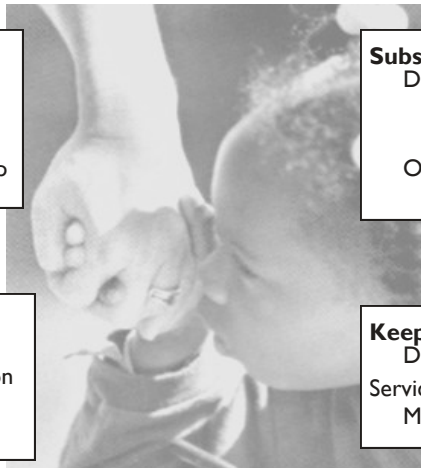
